Q. If a Franchisee provides his own premises for company hub, Is he entitled for monthly rent?

A. Yes. Even if the premises belongs to the Franchisee , company will pay rent as per prescribed norms and prescribed prices @Rs 10 per Sft depending upon the location

Q. Should Franchise need to take any licences or Registrations?

A. Franchisee is not required to take any licences /Registrations

Q. Who is responsible if the stock is damaged ?

A. During transit from Regional hub to Mandal hub and while delivery boy carrying stock for delivery – Company is responsible when @Mandal hub – It is responsibility of the franchisee

Q. How much space does it require? And is it needed to be on Main road?

A. Company requires 800-1000sft and it need not be on main road. It can be even in bylanes also, min 30ft road.

Q. What are the timings of Mandal hub?

A. 9AM to 6PM daily, 7 days a week

Q. Where do you procure the products from?

- A. Groceries directly from farmers, FMCG directly from Manufacturers
- Q. What is your Monthly targeted Sales base for each hub? A. Rs 16,00,000

Q. How much time it takes to reach the target?

A. 3-6 Months positively

Q. I have a store. Can I convert it into Mandal hub?

A. Yes. You can convert into Mandal hub provided it has required area. Rent will be paid as per the company fixed price policy per sft.
